

The purpose of this modification is to: 1) Correct the ceiling amount in accordance with Option Year #2 thereby increasing the ceiling by 241,065.40, from 465,353.50 to 706,418.90; 2) Provide incremental funding in the amount of \$143,000.00, thereby increasing the obligated amount of this contract from \$465,353.50 to \$608,353.50.

Accordingly, the contract is hereby modified:

1. Section C.18, C.19 and C.20, CONSIDERATION AND OBLIGATION - DELIVERY ORDERS..., of the SOW are DELETED entirely and REPLACED with the following:

"C.18 CONSIDERATION AND OBLIGATION - DELIVERY ORDERS

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$706,418.90**. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is **\$608,353.50**. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."
