

The purpose of this modification is to revise the indirect cost rates in accordance with an EPA audit for 2007 billing provisional rates. Accordingly the contract is modified as follows:

(a) Pending the establishment of final indirect rates which must be negotiated based on audit of actual costs, the contractor shall be reimbursed for allowable indirect costs as follows:
