
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to: 1) extend the period of performance for Task Order No. 2 and 2) increase the ceiling of the task order by \$9,808.00, and 3) provide incremental funding to Task Order No. 2.

1) The period of performance is hereby extended to September 30, 2007. FAR 52.217-8 applies.
 2) The ceiling is hereby increased by \$9,808.00 from \$137,281.96 to \$147,089.96.
 3) The funding is hereby increased by \$9,808.00 from \$132,456.47 to \$142,264.47.
