### **ANNOUNCEMENT OF CONTINUATION OF OPEN DISCUSSION ON 10 CFR PART 35 TRAINING AND EXPERIENCE (T&E) IMPLEMENTATION ISSUES (FSME-07-078)**

The Office of Federal and State Materials and Environmental Management Programs will be hosting a public teleconference for the Advisory Committee on the Medical Uses of Isotopes (ACMUI) August 16, 2007 from 1:00 p.m. to 3:30 p.m. EDT. The teleconference will be a continuation of the discussion which took place at the ACMUI meeting on Tuesday, June 12, 2007.
