We would like to respond to RCPD-07-004 Agreement State Authority to Fingerprint:

The State of Tennessee's preliminary research indicates that there is nothing in Tennessee law that would restrict the Division's ability to amend the licenses to require that employees with unescorted access to radioactive materials subject to NRC regulation submit to fingerprinting and criminal background checks.
