- SUMMARY
1. Mr. Dyer confirmed that "Suite 100" is no longer appropriate for their address in Item 2 of the license to be renewed.
 2. Mr. Dyer confirmed that the Gamma-Metrics Bulk Materials Analyzer model 2000 will remain in use at the Francisco Mine and that the two Sabia Model XC-50 Series Material Analyzers will remain in use, one each at the Farmersburg Mine and the Somerville Central Mine.
 3. In Item 7 of Attachment A to renewal application dated 3-13-07, it appears that a request is being made to replace the current Assistant RSO (ARSO), Chad Wirthwein, at the Somerville Central Mine, by Brad Lawyer. If so, please provide documentation (i.e. training certificate, etc.) confirming his successful completion of an RSO training course. Also, please provide a "Letter of Understanding" jointly signed by the newly appointed ARSO and a high level licensee management representative which both acknowledges the appointment and confirms that the ARSO understands his responsibilities and duties as an ARSO at the Somerville Central Mine. |
 4. The renewal application dated 3-13-07 which we received did not address Items 8 through 11 of Appendix B (the suggested format for providing information requested in Items 5-11 of NRC Form 313 for license renewal applications) of NUREG-1556, Vol. 4, published October 1998. Please respond to Items 8 through 11 fo Appendix B. (Item 10 has several subparts). This response can be accomplished by making a copy of and filling out the check list in Appendix B of NUREG-1556, Vol. 4. Please note that several of the Items (or subparts) do not require a response.


