

The purpose of this modification is to: (1) exercise option year one, in accordance with Federal Acquisition Regulation Clause 52.217-9, entitled "Option to Extend the Term of the Contract." As a result of this action (2) the period of performance is extended through September 30, 2008 and (3) the contract ceiling amount is increased by \$94,944.00 from \$142,197.40 to \$237,141.40, and (4) FY'07 funds are obligated in the amount of \$53,993.60, thereby increasing the obligated amount of the subject contract from \$142,197.40 to \$196,191.00.

Accordingly, the following changes are hereby made:

1. Under Section 17. SCHEDULE, Section (B) Supplies or Services, page 2:

a) The first sentence is revised to read as follows:
"This order is funded in the amount of **\$196,191.00**..."

b) The eighth sentence is revised to read as follows:
"...for this contract is **\$237,141.40**."
