 - d. Please state the minimum frequency that you will provide radiation safety reports to management.
 - e. Please list all other RSO positions you currently hold at NRC as well as Agreement States licensees facilities if any.
 - The checklist in your application references Appendix J in 10 CFR Part 35 for the training and experience of George J. Grcevich, M.D. Please make the proper current reference to 10 CFR 35.290.
- 5. Please confirm that you reserve the right to upgrade survey instruments as necessary as long as they are adequate to measure the type and level of radiation for which they are used. Also, the checklist states that the efficiency test results are attached, however, no results where attached. (Side note, I am not sure why this statement is in the application?)
- 6. Preceptor form on Page 4 is not dated. Please date provide page 4.
