The purpose of this modification is to: 1) Exercise Option Period One to extend the period of performance from May 1, 2007 through April 30, 2008; and 2) Increase the ceiling amount of the contract by \$250,019.84 from \$156,130.04 to \$406,149.88. Accordingly, the contract is hereby modified:

1. Section B.4 CONSIDERATION AND OBLIGATION–DELIVERY ORDERS (JUN 1988), paragraph (a), first sentence, is hereby deleted and substituted with the following in lieu thereof:

“(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$406,149.88.

2. Section F.2 DURATION OF CONTRACT PERIOD (MAR 1987), is hereby deleted and substituted with the following in lieu thereof:

“This contract shall commence on December 22, 2006 and will expire on April 30, 2008. The term of this contract may be extended at the option of the Government for an additional two one-year periods.”
