
Dear Sir or Madam:

This letter is to provide notification as required by 10 CFR 35.14(b) that effective July 1, 2007, UPMC Shadyside has appointed Michael A. Sheetz, M.S. to function as a temporary Radiation Safety Officer (RSO) in accordance with 35.24(c). It is also requested that he be named as the permanent Radiation Safety Officer for the above referenced license. Mr. Sheetz is currently the RSO for the University of Pittsburgh's NRC broad scope license (No. 37-00245-02). Attached is a delegation of authority letter from management for the RSO to perform his duties.

The University of Pittsburgh Radiation Safety Office has assumed responsibility for the management of the radiation safety program at UPMC Shadyside. It is intended that sometime in the near future this program will eventually be covered under the University's broad scope license activities and that the UPMC Shadyside's radioactive materials license will be terminated.




SUBJECT: Delegation of Authority

You, Michael A. Sheetz, have been appointed Radiation Safety Officer for UPMC Shadyside and are thereby responsible for ensuring the safe use of radiation. You are responsible for managing the radiation protection program; identifying radiation protection problems; initiating, recommending, or providing corrective actions; verifying implementation of corrective actions; stopping unsafe activities; and ensuring compliance with regulations. You are hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of radioactive material and radiation-producing equipment by employees who do not meet the necessary requirements, and shutting down operations where justified by radiation safety. You are required to notify management of situations where faculty or staff are not cooperating and not addressing radiation safety issues. In addition, you are free to raise issues with the Nuclear Regulatory Commission or Pennsylvania Bureau of Radiation Protection at any time.
