**PROGRAM SCOPE**

The licensee is a radiographer located in Louisville, Kentucky with authorization to use material under reciprocity at temporary job sites where the NRC maintains jurisdiction. The licensee was inspected at a temporary job site located in Jeffersonville, Indiana. This licensee had two card certified radiographers present on the job site. For use at the Indiana site, licensee used a 660B camera loaded with an iridium-192 source.

**Performance Observations**

At the time of the inspection, licensee was performing radiography at a temporary job site in Indiana. The inspector reviewed the paperwork associated with the use of the radiographic devices and interviewed personnel that performed radiography. All personnel appeared to possess an adequate level of knowledge of radiation protection. Survey instruments were determined to be within calibration as were pocket dosimeters and alarming rate meters.

During calendar year 2006, individuals present at the Indiana site did not exceed 3 Rem in exposure for the year.

The inspector verified that no source is stored on site. Each day that radiography is to take place, a source is brought to the site from the Louisville storage facility.

No violations of requirements were noted.


