Dear Ms. Morrell:

This letter is in response to the changes to your Emergency Plan (Plan) submitted by letter dated May 7, 2007. The changes to your Plan reflect a company name change, updated information, correction of typographical errors, a change to include new buildings, and the addition of a Site Area Emergency for Security Incidents. We have completed our review of the submitted changes and have determined that these changes do not decrease the effectiveness of the Plan, and thus were properly submitted under the provisions of 10 CFR 70.32(i).

The issuance of this letter closes activities related to TAC L32636.

The U.S. Nuclear Regulatory Commission (NRC) will incorporate a revised safety license condition S-2 into your license when the license amendment for the new container storage facility is issued.

License Condition S-2 will read as follows:

The licensee shall maintain and execute the response measures in the Emergency Plan, Revision 19, dated April 15, 2007, or as further revised in accordance with 10 CFR 70.32(I).
