Accordingly, the following changes are hereby 1. Section B.3 CONSIDERATION AND OBLIGATION, paragraph (c), is revised to read as follows: (c) The amount presently obligated with respect to this contract is \$1,370,000.00, of which \$1,268,636.44 represents reimbursable costs and of which \$101,363.56 represents the fixed fee. All other terms and conditions remain the same.
