One of the major concerns I've been hearing not only from the comments section but also from the direct contact I've had with some in the industry is will the gps tracking devices be required in the vehicles or on the equipment. The Vehicles would be inexpensive for the end users and would provide additional benefits. If it's required on devices and other equipment the cost could be high to outfit these devices with little or no real benefit other than loss recovery. If the loss recovery could be made by having the tracking devices in vehicles then why not since they would have additional benefit.
