Fitness for Duty Summary

Management Actions

1. During the six-month period ending June 30, 2007, NMC conducted 786 drug and alcohol tests at PBNP in accordance with 10 CFR26. Random test rates are as follows:

Point Beach Nuclear Plant	54%

For the semi annual reporting period ending June 30, 2007, one (1) worker was denied nuclear access after testing positive for drugs or alcohol. By test type, one (1) pre-access test was positive.

Pre-Access Positive Test

One (1) contractor employee tested positive for marijuana.

The individual listed above was denied access to NMC nuclear facilities.

2. For the semi-annual period ending June 30, 2007, all blind specimens submitted to PBNP's HHS-certified laboratory yielded expected results.
3. NMC has analyzed program performance data for the six-month period ending June 30, 2007, and has revised FFD procedures to incorporate enhancements as indicated by the analysis.

Reportable Events

There were no reportable events at PBNP, as defined in 10 CFR 26.73(a), during this reporting period.
