**INFORMATION REQUEST: STATES USE OF ESCROW ACCOUNTS OR GUARANTEES AS MECHANISMS FOR DECOMMISSIONING FINANCIAL ASSURANCE (FSME-06- 111)**

As stated in the September 18, 2006, All Agreement States Letter STP-06-087, the United States Nuclear Regulatory Commission (NRC) is proposing to amend its regulations to reduce the likelihood that a licensee will have insufficient funds to decommission its facility in accordance with 10 CFR 20, Subpart E, Radiological Criteria for License Termination. A regulatory change under consideration is to eliminate the escrow account as an approved financial assurance mechanism, and to require collateral for the unsecured Parent Company Guarantee and the unsecured Self-Guarantee financial assurance mechanisms. Reliance on these financial assurance mechanisms without regulatory change may increase the likelihood of future legacy sites due to the mechanisms ineffectiveness in bankruptcy actions.

At this time the License Termination Rule (LTR)-Prevention of Future Legacy Sites Working Group (WG) is in the process of completing the technical basis for this proposed rule. In order to complete this task, the WG is requesting the Agreement States to provide information on the use of the escrow account, Parent Guarantee, and Self-Guarantee as decommissioning financial assurance mechanisms in each State, whether these mechanisms are being used by the States, and the approximate total dollar value of each mechanism within those States.

The following is our response to FSME-06-111, INFORMATION REQUEST: STATES USE OF ESCROW ACCOUNTS OR GUARANTEES AS MECHANISMS FOR DECOMMISSIONING FINANCIAL ASSURANCE.

New York's Agreement State Program is divided among the State Department of Health, the New York City Department of Health and Mental Hygiene, and the State Department of Environmental Conservation (DEC). DEC does not issue radioactive materials licenses, but our agency does require financial assurance for hazardous waste facilities, under RCRA.

The New York State DEC's hazardous waste program does not use the escrow account as a financial assurance mechanism. We do use the financial test and corporate guarantee; however, we have no collateral requirement for either. Instead, the company or the guarantor must pass the financial test. We have been generally satisfied with the reliability of these mechanisms.

The approximate dollar value for the financial assurance we hold through the financial test is \$267,044,230, and through corporate guarantee, \$84,308,170.

This is in response to Information Request : States Use of Escrow Accounts or Guarantees as Mechanisms for Decommissioning Financial Assurance (FSME-06-111) dated December 13, 2006.

The Commonwealth of Massachusetts does allow the use of Escrow Accounts, Parent Guarantees and Self-Guarantees as decommissioning financial assurance mechanisms by its radioactive materials licensees.

Currently, our database indicates there are eleven (11) licensees using the escrow option, two (2) licensees using the parent guarantee, and three (3) licensees are self-guaranteed.

The eleven escrow accounts range from \$150,000 to \$15,000,000 and total \$19,650,000.

The two parent guarantees are \$225,000 and \$24,591,000 which total \$24,816,000.

All three self-guarantees are for \$750,000 to total \$2,250,000.

The total dollar value of all three types of decommissioning financial assurance mechanisms is \$46,716,000.

Per our discussion, following are the Illinois Emergency Management Agency, Division of Nuclear Safety (Agency) comments.

1. Agency regulations do not provide the option of an escrow account arrangement to satisfy financial assurance for qualifying licensees.
2. Agency regulations do allow a Parent Company Guarantee and Self-Guarantee arrangements provided the licensee meets the initial requirements and continues to pass annual financial tests established for the particular arrangement. Of the 71 licensees that have posted financial assurance with the Agency, only one Parent Company Guarantee for nearly \$35,000,000 has been filed.
3. With regard to NRC's consideration to require collateral for the unsecured Guarantees as a trust against bankruptcy actions, it is unclear as to the value of this proposal since failure of the annual tests provided for in the regulations should provide a trigger requiring posting of an alternate arrangement before a bankruptcy occurs. If collateral is required to support a Guarantee, then it is questionable whether the administrative costs associated with a Guarantee in addition to some form of secured funding provides any advantage to the operations of the licensee.
