To Whom It May Concern:

Gilmore & Associates, Inc. (G&A) requests that its Materials License be amended to reflect the addition of a permanent storage area for our portable density gauges. Due to the expansion of our firm in the recent years, provisions for gauge storage at our Allentown, Pennsylvania office has become a necessity. G&A has explored many options for additional storage space and proposes the following location:

The additional storage location is located in a shed at Commerce Corporate Center, 5100 Tilghman Street, Allentown, PA, 18104. The shed is located in the northwest corner of the property between the western corner of the 5100 building and Tilghman Street. The shed is located 85 feet from the closest workstation, and 10 feet from the edge-of-pavement along Tilghman Street.

The appropriate placard has been attached to the wall adjacent to the lock on the only access door to the shed. Inside the shed we have permanently attached a heavy gauge metal storage container to the floor and wall. The storage box has two hasps to lock the lid of the box. During storage of the gauges, both of these hasps will have locks. We have also permanently attached chains to the floor of the shed to wrap over the storage box in a pattern from front to back and side to side. During storage of the gauges, both of these locking systems will be locked as well. This shed is used for storage of field equipment and will be accessible to G&A survey personnel. However, only G&A personnel with the appropriate nuclear density gauge training will have access to the metal storage container that will house the nuclear density gauges.
