

The purpose of Modification No. 5 is: (1) to correct a typographical error cited in Block 12 "Accounting and Appropriation Data" of Modification No. 4; the amount obligated should read \$20,000.00, and (2) obligate additional funding in the amount of \$10,000, thereby increasing the obligated amount of the contract from \$84,000.00 to \$94,000.00.

Accordingly, the following change is hereby made:

Under Paragraph B.1 - **CONSIDERATION AND OBLIGATION-DELIVERY ORDERS** (JUN 1988), the first sentence of Subparagraph (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:

"B.1 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988)

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$328,635.00. "
- (b) The amount presently obligated with respect to this contract is \$94,000.00."
