





**Commissioner McGaffigan's Comments on SECY-07-0118**

I approve the end of periodic status reports on the progress of the G-8 countries in implementing the IAEA Code of Conduct. But I am concerned that we have no information about other countries' implementation dates or their methods of implementation. I think NRC needs particularly the latter information and any substantial differences with NRC, in order to benchmark our programs and potentially improve them.

For example, as part of the Commission's decisions next year on whether to expand the National Source Tracking System to Category 3 sources and whether to expand specific licensing to Category 3.5 sources, it would be useful to know international practices and international benchmarks. Therefore, I support the termination of this reporting requirement, but believe the Office of International Programs should support the Office of State and Federal Materials and Environmental Management Program's efforts to improve NRC's byproduct materials licensing and oversight programs by obtaining information on other nations' Code implementation to serve as benchmarks for the NRC effort.

Status Report on the Progress of the G-8 Countries in  
Implementing the IAEA Code of Conduct**

I approve of the staff's recommendation to discontinue the periodic updates on the G-8 countries' implementation of the Code of Conduct on the Safety and Security of Radioactive Sources, including the import/export guidance. I agree with the staff that these updates are no longer needed because the staff will be closely monitoring how other countries implement the Code. Additionally, as directed by the Commission in the Staff Requirements Memorandum for SECY-06-0171, "Analysis of 10 CRFR Part 110, Appendix P Implementation Issues," the staff was directed to keep the Commission informed of "methods and opportunities to achieve greater and more uniform adoption of the provisions of the Code of conduct by other countries." I look forward to seeing the staff's comprehensive review and analysis of other countries implementation of the Code of Conduct, including any recommendations the staff may have for enhancing the agency's approach its implementing.


