

14. THIS LICENSEE IS AUTHORIZED TO COLLECT LEAK TEST SAMPLES IN ACCORDANCE WITH THE PROCEDURES DESCRIBED IN THE LICENSEE'S APPLICATION DATED JUNE 16, 2000 FOR ANALYSIS BY SEAMAN NUCLEAR CORPORATION .
ALTERNATIVELY, LEAK TEST SAMPLES MAY BE COLLECTED AND/OR ANALYZED BY OTHER PERSONS SPECIFICALLY AUTHORIZED BY THE CABINET, U.S. NUCLEAR REGULATORY COMMISSION OR AN AGREEMENT STATE.
15. SEALED SOURCES CONTAINING RADIOACTIVE MATERIAL SHALL NOT BE OPENED OR REMOVED FROM THEIR RESPECTIVE SOURCE HOLDERS BY THE LICENSEE.
16. THE GAUGE OR ITS CONTAINER MUST BE LOCKED WHEN IN TRANSPORT, STORAGE OR WHEN NOT UNDER THE DIRECT SURVEILLANCE OF AN AUTHORIZED USER.
18. THE LICENSEE SHALL CONDUCT A PHYSICAL INVENTORY EVERY SIX (6) MONTHS TO ACCOUNT FOR ALL SEALED SOURCES RECEIVED AND POSSESSED UNDER THE LICENSE. THE RECORDS OF THE INVENTORIES SHALL BE MAINTAINED FOR FIVE (5) YEARS FROM THE DATE OF THE INVENTORY FOR INSPECTION BY THE CABINET, AND SHALL INCLUDE THE RADIONUCLIDES, QUANTITIES, MANUFACTURER'S NAME AND MODEL NUMBERS, LOCATION OF SEALED SOURCES, AND THE DATE OF THE INVENTORY.
19. THE LICENSEE MAY TRANSPORT RADIOACTIVE MATERIAL, OR DELIVER RADIOACTIVE MATERIAL TO A CARRIER FOR TRANSPORT, IN ACCORDANCE WITH THE PROVISIONS OF 902 KAR 100:070, AND OTHER DEPARTMENTS OF THE COMMONWEALTH OF KENTUCKY HAVING JURISDICTION.


