SUBJECT: NRC INSPECTION REPORT NOS. 50-390/89-07 AND 50-391/89-07

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by M. W. Branch and G. A. Walton on May 22, 1989 - June 16, 1989. The inspection included a review of activities authorized for your Watts Bar facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

This inspection report also documents an inspection at your Knoxville Office concerning training of TVA engineering personnel. NRC's concerns regarding TVA's training deficiencies and failure to resolve a previous noncompliance are being provided by separate correspondence.

Within the scope of the inspection, no violations or deviations were identified.

Four unresolved items are identified in the inspection report. These matters will be pursued during future inspections.

In accordance with Section 2.790 of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
