SUBJECT: NRC INSPECTION REPORT NOS. 50-390/87-06 AND 50-391/87-06

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by W. M. Sartor on April 28-29, 1987. The inspection included a review of activities authorized for your Watts Bar facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report and involved followup of your staff's actions taken in response to previous emergency preparedness exercise findings.
