SUBJECT: NRC INSPECTION REPORT NOS. 50-390/87-08 AND 50-391/87-08

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by W. J. Ross on May 21-22, 1987. The inspection included a review of activities authorized for your Watts Bar facility and included plant lay-up and water chemistry control.
