The purpose of this modification is to: 1) provide incremental funding in the amount of \$165,000.00 in support of the "Smooth Move Project" 2) increase the contract ceiling and 3) revise Section B.5 "Consideration and Obligation-Work Orders."

1) Funds in the amount of \$165,000.00 are hereby obligated. Funds are increased by \$165,000.00 from \$1,018,029.76 to \$1,183,029.76.

2) The contract ceiling is hereby increased by \$165,000.00 from \$1,020,206.24 to \$1,185,206.24.

3) Section B.5 "Consideration and Obligation-Work Orders" the second sentence of subparagraph (b) is hereby revised to read as follows: "(b) the amount currently obligated on this contract is \$1,183,029.76"

This modification obligates FY2007 funds in the amount of \$165,000.00.
