The purpose of this modification is to exercise the optional period of performance for the period October 1, 2007 through September 30, 2008, and to increase the ceiling of the task order by \$85,521.

Accordingly, the following changes are hereby made:

1. Section B - CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988), Paragraph "a" is hereby deleted in its entirety and replaced with the following:

"a. The total estimated cost to the Government for full performance of this task order is \$195,346, of which the sum of \$181,102 represents the estimated reimbursable costs, and of which \$14,244 represents the fixed fee."

2. Section C - PERIOD OF PERFORMANCE, is deleted in its entirety and replaced with the following:

"The period of performance of this task order shall be December 6, 2006 - September 30, 2008."

A summary of obligations under this order, from date of award through this modification, is given below:

FY06 obligation amount: \$15,000 (transferred from Basic Contract NRC-02-06-021)  
FY07 obligation amount: \$60,000
