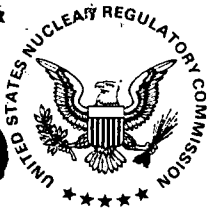

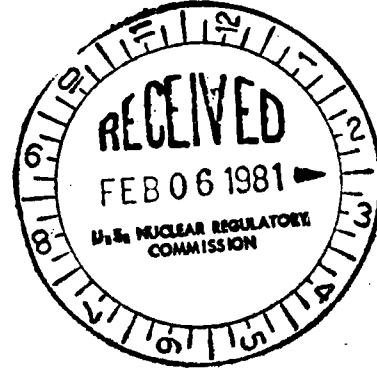

Your positive response to the presentation is appreciated and should enhance communications with us in areas pertinent to safe reactor operations.


