
This refers to the inspection conducted by M. Thomas of this office on March 3-6, 1980 of activities authorized by NRC Construction Permit Nos. CPPR-91 and CPPR-92 for the Watts Bar Nuclear Plant facility, and to the discussion of our findings held with J. E. Wilkins at the conclusion of the inspection.


One new unresolved item resulted from this inspection and is discussed in the enclosed report. This item will be examined during subsequent inspections.
