2. Exit Interview

The inspection scope and findings were summarized on April 4, 1980, with those persons indicated in paragraph 1 above.

3. Licensee Action on Previous Inspection Findings

Not inspected.

4. Unresolved Items

Unresolved items were not identified during this inspection.

Construction Verification and System Transfers

The inspector participated in an inspection of construction verification and system transfers, which was conducted March 24-26, 1980. The results of that inspection are documented in NRC Inspection Report No. 50-390/80-08.

6. Independent Inspection Effort

The inspector performed numerous tours of the facility for his own plant familiarization. This effort focused on inspector familiarization with individual plant systems and review of the as-built plant configuration. The inspector established contact with the Division of Power Production and Division of Construction management personnel listed in paragraph 1, and observed their internal working relationships.

The inspector also interfaced with other NRC Region II inspectors listed in paragraph 1 during the course of their inspections.

The inspector attended the TVA training courses required for unescorted access to the Sequoyah facility. Most of this training will be transferrable to the Watts Bar facility at the appropriate phase of security program implementation.

No items of noncompliance or deviations were identified.
