SUBJECT  
Control No. 316296 – Re - Amendment request, for License No. 21-08606-08, by letter dated May 24, 2007, to request: (1) a change in the individual serving as the Radiation Safety Officer; and (2) a change in name of the licensee.

SUMMARY  
In a telephone conversation with Mr. Nestle on this date, he confirmed his knowledge of his appointment as replacement RSO and of the duties and responsibilities the position entails. Also, the need for providing the following supplemental information was discussed:

1. Please provide a copy of your certificates (or name inclusion in an official listing) confirming your CHP certification by the American Board of Health Physics and NRRPT certification by the National Registry of Radiation Protection Technologists as referenced in subject amendment request.
2. The May 24, 2007, amendment request notes a name change for the licensee, with one word differing from that shown in the letter head. Please clarify whether the second line should read "Palisades **Power** Plant" or "Palisades **Nuclear** Plant". Also, please clarify whether or not "**Memorial**" should be included in the third line of licensee address, as it is not included in the current license.
3. Also, please clarify whether or not a "Transfer of Control" or "Ownership" is also involved with the change in name of the licensee. If it is, then please provide full information regarding the ownership change as per guidance in NUREG-1556, Vol. 15. Appendix F (copy enclosed) of that document, list six questions that the licensee is to provide a written response to. Please respond accordingly. This response should be signed by a high level management representative of the purchasing entity.

### Information Needed for Transfer of Control

#### Definitions:

**Control:** Control of a license is in the hands of the person or persons who are empowered to decide when and how that license will be used. That control is to be found in the person or persons who, because of ownership or authority explicitly delegated by the owners, possess the power to determine corporate policy and thus the direction of the activities under the license.

**Transferee:** A transferee is an entity that proposes to purchase or otherwise gain control of an NRC-licensed operation.

**Transferor:** A transferor is an NRC licensee selling or otherwise giving up control of a licensed operation.

Licensees must provide full information and obtain NRC's *prior written consent* before transferring control of the license. Provide the following information concerning changes of control by the applicant (transferor and/or transferee, as appropriate). If any items are not applicable, so state.

1. Provide a complete description of the transaction (transfer of stocks or assets, or merger). Indicate whether the name has changed and include the new name. Include the name and telephone number of a licensee contact who NRC may contact if more information is needed.
2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel.
3. Describe any changes in the organization, location, facilities, equipment or procedures that relate to the licensed program.
4. Describe the status of the surveillance program (surveys, wipe tests, quality control) at the present time and the expected status at the time that control is to be transferred.
5. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.
6. Confirm that the transferee will abide by all constraints, conditions, requirements and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.
