1. Please note that the following facilities are listed on NRC License # 29-30448-01 (Diagnostic and Clinical Cardiology),:
 - a) 769 Northfield Avenue Suite 130, West Orange, NJ
 - b) 769 Northfield Avenue Suite 220, West Orange, NJ
 - c) 5 Franklin Avenue, Suite 503, Belleville, NJ
2. Diagnostic and Clinical Cardiology will transfer ownership of the 769 Northfield Avenue Suite 130, West Orange, NJ facility to Essex Cardiology Group on October 1, 2007. A new license application is attached listing Stephen Levy M.D. as the administrator.
3. 


