SUBJECT: Reply to a Notice of Violation

To Whom It May Concern:

I am in receipt of your letter dated July 18th, 2007, and the accompanying notice of violation. I am also in receipt of an extension of time until September 7, 2007, in which to respond to the notice of violation from Mr. David Collins. Per the parameters set forth in the Notice of Violation, this letter responds to 1) the reason for the violation, 2) the corrective steps that have been taken and the results achieved, 3) the corrective steps that will be taken to avoid further violations, and 4) the date when full compliance will be achieved.

On May 23rd, 2007 two (2) violations were identified: a potential violation for not periodically reviewing the radiation protection program content and implementation from January 2006 through May 23, 2007 and a potential violation for the individual performing RSO duties not being the named individual on the license.

- A. A violation of 10 CFR 20.1101(c) which states "from January 2006 through May 23, 2007, the licensee did not perform a review of the radiation protection program content and implementation."

From January 2006 through May 23, 2007, the licensee had meetings with senior managers and discussions with employees to ensure that all daily readings and inspections were in full compliance. Additionally, the licensee discussed with senior managers strategic changes including transfer of the responsibilities to another component of the USCP.

In order to document the review of the radiation protection program content and implementation, procedures will be created for an annual review. The Hazardous Materials Response Team (HMRT), who will ensure that this annual review occurs in a formalized and timely fashion, will implement these procedures. HMRT will develop these procedures and measures to ensure full compliance by October 31, 2007.

As we move forward, HMRT will continue to oversee the daily VACIS operations, including review and inspections of equipment, as well as the annual review of the radiation protection program content and implementation.

- B. A violation of condition 12 of License No. 08-30729-01 which requires that the Radiation Safety Officer be the named individual.


In 2006, the named RSO, Rita Purvis, took leave from the USCP. At this point in time, Tasheka Westbury took over her responsibilities as RSO. Ms. Westbury attended the Radiation Safety Academy and received RSO training to serve as RSO (certificate attached). It was anticipated that Ms. Purvis would return to her responsibilities, however this did not occur. This violation occurred because, due to unforeseen circumstances of Ms. Purvis' situation, an amendment to the license was not filed.

Contemporaneous to this response letter, the USCP is filing an amendment to the license. (Copy attached) This amendment will include a new license owner, and a new RSO. In order to ensure that this violation does not happen again, standard operating procedures will be created to clearly delineate the protocols for amending the license. Full compliance to this violation will be achieved as soon as the NRC processes this amendment.

The USCP takes the safety of our radiation program very seriously and believes the corrective measures discussed above will ensure that the USCP is in full compliance of NRC regulations and that there will be no recurrence of violations, perceived or otherwise. The USCP appreciates the assistance and guidance the NRC has provided and looks forward to working together to ensure safety with our radiation protection program.

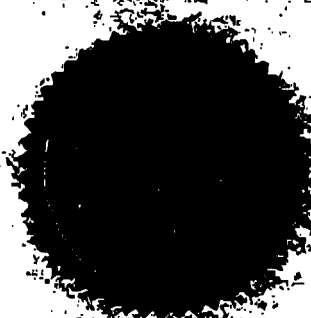


Dear Ms. Miller,

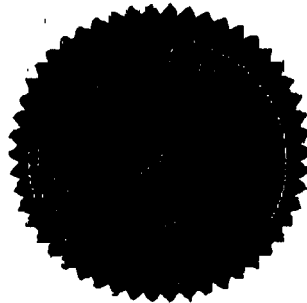

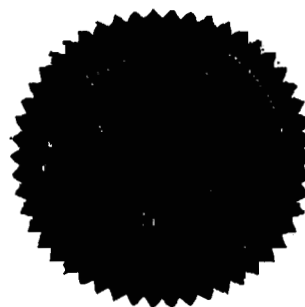
