Subject: License Amendment

The Menlo Park Radiation Safety Committee (RSC) is requesting an amendment to the facility NRC license (04-06674-07) to correct a discrepancy between the license and the inventory of a user operating under the license. The user has on hand ²³²Uranium/²²⁸Thoruim spike solutions that were used for rock and minerals analysis. The thorium is listed on the user's permit and the license; however, the uranium is not. The discrepancy was the result of an oversight when the user originally applied for a permit with the license in November 2001 and was discovered this year during a review of the inventory. The spike solutions (quantity and activity of 232U are listed below) have always been in the secure custody of the user.

The ²³²U is distributed among three containers:

- 1. stock solution: 75g, 7.5N HNO3, 5.73E-02 µCi
- 2. dilution from stock: 450g, 2N HNO3, 2.37E-03 µC

3. dilution from stock: 10g, 2N HNO3, 5.65E-05 μ Ci Summary: 535 grams ²³²U with a total activity of 5.97E-02 μ Ci

The RSC is requesting that the license be amended as follows:

- Add ²³²U (Category 6. Byproduct, source, and or special nuclear material).
- List the chemical and/or physical form (Category 7) as Any. •
- The maximum possession limit (Category 8) is 20 microcurries
- Authorized Use is For use in sample analysis of rocks and minerals

The RSC requests that this amendment be expedited. Please contact me with any questions regarding this request.
