This refers to the NRC inspection conducted October 30 - November 3, 1995, at the Watts Bar facility. The purpose of the inspection was to determine whether activities authorized by the construction permit were conducted safely and in accordance with NRC requirements.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Within the scope of the inspection, violations or deviations were not identified.
