Dear Mr. Kelman:

This is in reference to the letter dated January 2, 2007, from Dawn Dietz of your staff. The letter requested to renew and amend Nuclear Regulatory Commission License No. 37-28413-02. The amendment request was to authorize the use of licensed material which is currently authorized for storage only at your facility. **Please note that this office did not receive the above referenced letter until April 29, 2007, when it was sent to this office via facsimile.**

The letter did not include the information required for renewal of license therefore, I contacted Ms. Dietz and walked her through the NRC's web site step by step to the document NUREG 1556, Vol 4, that contains the information and forms necessary to complete the renewal application. Most of the information on the forms needed just check marks which should not have taken more than a few minutes to complete. This was in May of this year. In August, I contacted her again to remind her to submit the information and she promised to send it as soon as possible, and I provided her with our fax number. Two weeks later I left a message on her voice mail reminding her that this office has not received the requested information. However, as of the date of this letter, this office has not received the requested information.

Additionally, on September 18, 2007, I tried to contact Mr. Matt **Horton** of Philotechnics, Ltd., because the letter also requested that he be named Radiation Safety Officer (RSO) on the license. Philotechnics office told me that they did not have any one by the name of Matt Horton, but they did have one individual named Matt **Norton**. Mr Norton appeared surprised because he was not aware that you had retained him as RSO, and that he had never been to your facility.

**Please be reminded that 10 CFR 30.9 requires, in part that the information provided to NRC by a licensee be complete and accurate in all material respects.**

Please be reminded that currently, your license does not authorize use of licensed material, therefore, until the license is amended to authorize use of licensed material, the material must remain in storage.

Your license can not be renewed until we receive the requested information. Therefore, we must receive the requested information within 15 days from the date of this letter. We will continue our review upon receipt of this information.
