Ladies and Gentlemen:

In accordance with 10 CFR 50.46, "Acceptance criteria for emergency core cooling systems for light-water nuclear power reactors," paragraph (a)(3)(ii), Carolina Power & Light Company (CP&L), now doing business as Progress Energy Carolinas, Inc., is submitting the annual report of the emergency core cooling system (ECCS) evaluation model changes and errors for the Brunswick Steam Electric Plant (BSEP), Unit Nos. 1 and 2.

This report covers the period from August 16, 2006, through August 15, 2007. The previous annual report for BSEP, Units 1 and 2, was submitted by CP&L's letter dated September 28, 2006. Since the previous annual report, no error or change notifications have been issued by Global Nuclear Fuels which affect the ECCS evaluation model for BSEP, Units 1 and 2. Therefore, the estimated licensing basis peak cladding temperatures (PCTs) remain unchanged from the values previously reported (i.e., <1567° F for GE14 fuel).

A. Introduction

The documentation herein supports compliance to 10 CFR 50.46 (a)(3)(ii) (Reference B.1) requiring licensees of light-water nuclear power reactors to report the nature of a change or the error in an ECCS evaluation model to the Commission at least annually. The purpose of this assessment is to support the 2007 Brunswick Annual 10 CFR 50.46 Report. The requirements of 10 CFR 50.46 with regard to the identification and evaluation of changes to or errors in the LOCA evaluation model are implemented by Progress Energy procedure REG-NGGC-0006 (Reference B.2).

Therefore, there are no changes to (or errors in) the Brunswick LOCA evaluation model to record for the Brunswick 2007 10 CFR 50.46 assessment period. The assessment of the Brunswick LOCA evaluation model in Reference B.5 remains valid.
