In accordance with your application dated August 21, 2004, supplement letters dated September 25, 2004 and February 28, 2005, and pursuant to Part 70 to Title 10 of the Code of Federal Regulations, Materials License SNM-1373 is hereby amended to authorize additional activities in the Idaho Accelerator Center. Accordingly, Conditions 9 and 10 have been revised as follows:
