

The purpose of this modification is to (1) exercise option year 1 thereby extending the period of performance from 9/28/07 to 9/28/08, (2) provide funding in the amount of \$31,697.00 which increases the total obligations from \$139,702.00 to \$171,399.00 and (3) increase the contract ceiling by \$31,697.00 from \$139,702.00 to \$171,399.00. Accordingly the contract is modified as follows:

Refer to Section B.1 entitled "CONSIDERATION AND OBLIGATION – FIRM FIXED PRICE (JUN 1988)" first sentence is deleted in its entirety and replaced with the following:

"The firm fixed price of this contract is \$171,399.00"

Refer to Section C.4 entitled "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)" first paragraph is deleted in its entirety and replaced with the following:

"This contract shall commence on 9/29/2006 and will expire on 09/28/2008. The term of this contract may be extended at the option of the Government for an additional 3 one-year options."

A summary of obligations for this contract, from the date of award through the date of this action, is given below:

Total FY2006 Obligations:	\$138,802.00
Total FY2007 Obligations:	\$ 32,597.00
Cumulative Total of NRC Obligations:	\$171,399.00

The action obligates FY07 funds in the amount of \$31,697.00.
