Dear Ms. Morrell:

This letter is in response to the administrative changes to your Emergency Plan (Plan) submitted by letter dated June 12, 2006. The changes to your Plan reflect name changes, a change of frequency for independent audits of the Plan from annually to biannually, clarification of primary areas of safety, and minor updates to appendixes A, B and C. We have completed our review of the submitted changes and have determined that these changes do not decrease the effectiveness of the Plan, and thus were properly submitted under the provisions of 10 CFR 70.32(i). The issuance of this letter closes activities related to TAC L31957.

Safety Condition S-2 has been updated to reflect the most recent revision to the Emergency Plan dated September 13, 2004 (reference the U.S. Nuclear Regulatory Commission (NRC) letter dated November 4, 2004). Thus, License Condition S-2 has been revised and reads as follows:

S-2 The licensee shall maintain and execute the response measures in the Emergency Plan, Revision 18, dated May 1, 2006, or as further revised by the licensee, consistent with 10 CFR 70.32(i).

All other conditions of this license shall remain the same. Enclosed is a copy of the revised Materials License SNM-42 (Enclosure).
