

Dear Ms. Morrell:

This refers to your letter dated March 9, 2005, in which your facility submitted a revised highly-enriched uranium (HEU) Fundamental Nuclear Material Control (FNMC) Plan. We have completed the review of the submitted changes and have determined that these changes are acceptable. Accordingly, pursuant to Part 70 of Title 10 of the Code of Federal Regulations, Materials License SNM-42 is hereby amended to incorporate your revised HEU FNMC Plan. Thus, Safeguards License Condition SG-5.1 has been revised to include the revision of March 9, 2005, and to read as follows:

SG-5.1 To achieve the performance objectives of 10 CFR 74.51(a) and maintain the system capabilities of 10 CFR 74.51(b) with respect to all activities involving special nuclear material, the licensee shall follow the General Discussion and Chapters 1.0 through 4.0 (all pages dated March 9, 2005) of its "Fundamental Nuclear Materials Control Plan - Special Nuclear Materials License 42." Any revisions to this Plan shall be made in accordance with, and pursuant to, either 10 CFR 70.32(c) or 70.34.

Enclosed are copies of the revised Materials License SNM-42 and the Safeguards Evaluation Report (SER) which includes the Categorical Exclusion determination.
