Dear Ms. Petrick:

This is in reference to your letter dated August 16, 2007 requesting to amend Nuclear Regulatory Commission License No. 37-30208-01. In order to continue our review, we need the following additional information:

To list Dr. Huber as the Radiation Safety Officer on the license, he must complete the requirements as specified in 10 CFR 35.50. The requirements of a preceptor Radiation Safety Officer statements are required. A preceptor Radiation Safety Officer must attest to Dr. Huber's qualification. It is recommended to document his qualifications on the enclosed NRC Form 313A (RSO). Since Dr. Huber is currently an authorized user section 4 of Part I could apply. Please note that the preceptor attestation includes three sections.
