- 9. Page 8, Section 2.5 Review of Changes in Plant Areas, 1st sentence. Add the word "plans," between "...changes to site areas, SSCs," and "and activities that could...".
- 10. Page 8, Section 2.5 Review of Changes in Plant Areas, 3rd sentence. Add the words "or detects" between the words "...that interrupts" and "adversary access...".
- 11. Page 8, Section 2.5 Review of Changes in Plant Areas, 4th sentence. Add the words "plans and" between the words "...site's operational" and "procedures, and ...".

- 26. Page 10, Section 2.9 Screening Questions for Safety, 1st ¶. End the second sentence after the words "…related regulatory requirements" and begin new last sentence that reads "These could be applied or adapted to meet the objective of identifying potential adverse interactions between security and safety activities."

- 27. Page 10, Section 2.9 Screening Questions for Safety, 2nd ¶, 1st line. Change the word "effecting" to "affecting" and add the word "response" between the words "…emergency" and "plans in accordance…"
- 28. Page 10, Section 2.9 Screening Questions for Safety, 2nd ¶, 2nd line. Delete the word "in" and change the word "effect" to "effective".
- 29. Page 10, Section 2.10 Screening Questions for Security, 1st ¶, 1st sentence. Add the words "implementing procedures" between the words "...site security plans," and "and the bases...".
- 30. Page 10, Section 2.10 Screening Questions for Security, 1st bullet. Change the word "systems" to "system" and add the words "elements or" between the words "...a security protection" and "system to perform...".
- 31. Page 10, Section 2.10 Screening Questions for Security, 2nd bullet. Add the words "element or" between the words "...security protection" and "system performance...".
- 32. Page 11, Section 2.10 Screening Questions for Security, 5th bullet on page. Add the words "or LLEA" between the words "...security response force" and "(personnel and/or...".
- 33. Page 11, Section 2.10 Screening Questions for Security, 6th bullet on page. Add the words "or LLEA" between the words "...capability of security" and "(personnel and/or...".
- 34. Page 11, Section 3.1 Frequency of Reviews and Audits. The reference to 10 CFR 73.55(g)(4)(i)(A) or (B) is applicable to the current regulation. In the proposed rule, the correct reference is 10 CFR 73.55(n)(1)(i) and (ii).
 - Additionally, this section is confusing as written. Reword the 3rd sentence to read "Licensees shall review the physical protection program on the following schedule:". Change the sentence after the bullets to read "As specified in 73.55(n)(2)(ii), the effectiveness of the safety/security interface program must be reviewed at least every 24 months by individuals independent of those personnel responsible for program management and any individual who has direct responsibility for implementation of the onsite physical protection program."
- 35. Page 12, Section 3.2 Reviews of Implementing Procedures, 1st sentence. Change the end of the sentence to read "...with the licensee's safety and security programs."
