The purpose of this modification is to:

- 1) Exercise Option Year One, (September 19, 2007 through September 18, 2008) of the contract in accordance with Federal Acquisition Regulation (FAR) Clause 52.217-9, Option to Extend the Term of the Contract, thereby extending the term of the contract through September 18, 2008. ICF waived the requirement for a preliminary written notice of the Government's intent to exercise this option via email on September 13, 2007.
- 2) Increase the ceiling of the contract by \$402,543.74, from \$768,977.33 to \$1,171,521.07.
- 3) Change the NRC Project Officer from Carolyn Boyle to Edna Knox-Davin.
- 4) Revise the appropriation data for this contract as shown on Page 1, Block 12.

Accordingly, the contract is hereby modified as follows:
