SUBJECT: NRC INSPECTION REPORT NOS. 50-390/94-08 AND 50-391/94-08

This refers to the NRC inspection of the Heating, Ventilation, and Air Conditioning Duct and Duct Supports Corrective Action Program at the 75 percent implementation milestone conducted by M. M. Glasman on January 31 through February 11, 1994. The inspection included a review of activities authorized for your Watts Bar facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of duct supports, duct spans, associated calculations, procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, the Heating, Ventilating and Air Conditioning Duct and Duct Supports Corrective Action Program was being implemented in a satisfactory manner at the 75 percent milestone.

The enclosed inspection report identifies activities that violated NRC requirements that will not be subject to enforcement action because your efforts in identifying and/or correcting the violation meet the criteria specified in Section VII.B. of the Enforcement Policy.
