Enclosed is Amendment No. 12 to your NRC Material License No. 24-32195-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that we were unable to approve James Douglas Schoen, M.D. as an authorized user for the use of materials in 10 CFR 35.100, 35.200, 35.300 and 31.11 at this time because the information in your letter dated June 22, 2007, was insufficient to complete our review.

If you wish to pursue this matter, please submit the following information, addressed to my attention and referenced as "additional information to control number 316341."

Dr. Schoen was not approved as an authorized user for the use of materials in 10 CFR 35.100, 35.200, 35.300 and 31.11 because we cannot accept Dr. Schoen's specialty board certification, as of October 24, 2005. Dr. Schoen's preceptor forms 313AUD relied exclusively on this board certification. Therefore, it does not appear that Dr. Schoen meets the requirements in 10 CFR 35.190, 35.290, 35.390, 35.57, 35.13 and 35.59, as appropriate.

<u>Please refer</u> to the regulatory requirements in 10 CFR 35.190, 35.290, 35.390, 35.57, 35.13 and 35.59, as well as section 8.11, item 7 and Appendices B, D and E in NUREG 1556, Vol. 9, Rev. 1, for assistance in preparing your written response to demonstrate that Dr. Schoen's training and experience meet the appropriate regulatory requirements for the modality he seeks authorization for.

In addition, please note that NRC Form 313 requires the applicant, by his/her signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for an application for medical use must be the licensee's management, as required by 10 CFR 35.12(a).

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
