# NFPA 805 Status - Current Focus

- Complete NEI 04-02 Appendix B-3
  - Prepared, under review
  - NRC may have additional comments
- Non-Power Operations Implementation
- PRA quantification
- Transition Program Change Process
- Develop Draft LAR, FSAR outline
- Selected FAQs to NRC by September
  - NEI 04-02 revision to NRC mid January 2008





# NFPA 805 Harris Key Milestones

- Internal Event PRA Limited Peer Review September 2007
- Complete 'Rough in' FSA October 2007
  - Initial PRA Quantification complete
  - Includes draft Transition Program Changes
  - Initial strategies, mod scope identified
- Fire PRA NRC Audit February 2008
- LAR enter internal review April 2008
  - Final FSA, program changes, strategies complete
  - Baseline Fire PRA established
- LAR May 31, 2008
- NFPA 805 Program Implementation mid 2009
- Full NFPA 805 compliance December 31, 2010

# NFPA 805 Transition Change Process

- Inputs to change evaluation team to 'rough in' phase
  - B3 results
  - CLB deficiencies by fire area
  - Fire PRA scenario development by ignition source
  - Preliminary Quantification ranking
- Output
  - PRA model updates / SSA model updates
  - Transition change evaluation scenarios
  - Potential plant modifications





# NFPA 805 Transition Change Process

- First few fire areas/compartments exercise most of the tool box tools
  - Expect to learn how to succinctly get to the resolutions this will save time
- Sent a sample to NRC
  - FSA/Change Evaluation for fire area 1-BAL-C
  - Supporting information:
    - B-3 table
    - Fire model input
    - Project procedures
