SUBJECT: REQUEST FOR ADDITIONAL INFORMATION FOR SILEX TEST LOOP
AMENDMENT REQUEST (TAC L32461)

Dear Mr. Murray:

This refers to your request for a license amendment to Materials License SNM-1097 for a SILEX test loop, submitted by letter dated June 29, 2007.

Our technical review of the Integrated Safety Assessment Summary has identified some areas that require additional information. The additional information, specified in the enclosure, should be provided within 30 days from the date of this letter. We request a reply in writing, even for expanded descriptions or examination of design drawings that are best provided by a site visit. Note that the classification level of any written response should be properly marked to protect sensitive information.

Because the changes to the Fundamental Nuclear Material Control Plan were submitted via separate letter dated August 21, 2007, other information regarding the new test loop material balance area may be required at a later date.

Pending timely resolution of these items, we anticipate supporting the original project schedule. We will promptly communicate any significant changes to this schedule.
