In accordance with the task order procedures of the subject contract, this letter definitizes Modification No. 1 to Task Order No. 13. This effort shall be performed in accordance with the enclosed Statement of Work, and the Contractor's technical proposal dated August 30, 2007 and revised on September 14, 2007. Modification No. 1 to Task Order No. 13 shall be in effect from July 2, 2007 through October 22, 2008, with a total cost ceiling for Task Order 13 of \$914,717 (inclusive of the \$100,000 authorized by email dated 9/7/2007). The amount of \$852,770 represents the total estimated reimbursable costs, and the amount of \$61,947 represents the fixed fee for this task order.

This modification provides full funding in the amount of \$764,717 (note that \$150,000 of funding was provided previously on the original order).
