RE: Change of Ownership

To Whom It May Concern: 03036049

I am writing to notify you that as of October 1, 2007 there was a change in ownership of Jefferson Regional PET Scanning, GP, license number 37-30741-01. The original owners were a partnership involving Jefferson Regional Medical Center and James Zelch, MD, each having 50% of the company. Jefferson Regional Medical Center has purchased from Dr. James Zelch his 50% interest, and now owns in whole Jefferson Regional PET Scanning, GP.

A name change will occur, but will not be effective until January 1, 2008. The name will be changed to JRMC Diagnostic Services, which is still under Jefferson Regional Medical Center's ownership. I will request an amendment on the license for the name change 30 days prior.

Dr. James Zelch will no longer be the medical director on the license, and will be replaced by Teresita Enriquez, MD. Michael Paley, MD and Allison Pryce, DO, will need to be removed as authorized users. Richard Black, DO and Teresita Enriquez, MD will remain on the license.


