Of note, a third facility of Bon Secours, covered under their same license, has been purchased by Henry Ford Hospital and is being placed under the Henry Ford Hospital license. Amendment No. 83 to your NRC Material License No. 21-01333-01 is being issued concurrently with both a license amendment terminating Bon Secours Cottage Health Services License No. 21-16868-01 and an amendment placing the third Bon Secours facility under Henry Ford Hospital License No. 21-04109-16. Please note that the changes made to your license are printed in **bold** font.
