The purpose of this modification number M012 is to provide incremental funding for the amount of \$6,330, thereby increasing the amount obligated from \$196,460 to \$202,790.

Accordingly, the contract is hereby modified as follows:

1. On page B-5, Section B.4., paragraph (b), first sentence is deleted and replaced with the following:  
"(b) The amount presently obligated with respect to this contract is \$202,790." The following is a summary of obligations from the date of award through the date of this action:  
FY2004 Obligations: \$1,637; FY2005 Obligations: \$53,883; FY2006: \$62,460; FY2007: \$28,480; and FY2008: \$6,330.

All other terms and conditions remain unchanged.
